3,410	11/2/64	Repeals Chapter 1102, enacts a new Chapter 1102 and adopts the 1962 National Electrical Code without amendment.
4,080	9/27/66	Repeals Section 1102.020 and enacts a new Section 1102.020 which adopts the 1965 National Electrical Code without amendments.
4,511	11/16/67	Amends permit and inspection fees.
4,745	6/18/68	Amends section 1102.050 relating to the powers and duties of the Supervision of Electrical Inspection and requires that power to buildings, in violation of the code or that are unsafe, be disconnected.
5,054	5/19/69	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1968 National Electrical Code without amendments.
6,399	7/17/72	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1971 National Electrical Code.
6,493	10/6/72	Repeals Sections 1102.030, 1102.040, 1102.050, 1102.100 and enacts new sections of the same numbers relating to the definition of building official, establishes the Office of Electrical Inspection, Power and Duties of the Supervisor of Electrical Inspections, Permits and Inspection Fees.
7,414	3/3/75	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1975 National Electrical Code without amendments.
8,288	6/24/77	Repeals Section 1102.110 and enacts new Sections 1102.110 and 1102.125 that allows homeowners to perform electrical installations and repairs on their own homes.
8,725	6/2/78	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1978 National Electrical Code without amendments.
9,632	2/28/80	Repeals Section 1102.125 and enacts a new Section 1102.125 that limits homeowner permits to repairs and modifications.
10,164	4/14/81	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1981 National Electrical Code without amendments.
10,465	12/24/81	Amends Sections 1102.100 and 1102.110 relating to permit, inspections, examinations, and licensing fees.
10,735	9/2/82	Amends inspection and permit fees.
11,545	6/5/84	Repeals Chapter 1102 and enacts a new Chapter 1102 that adopts the 1984 National Electrical Code without amendment. Establishes new fees for permits, plan reviews and inspections.
13,101	2/13/97	Amends inspection and permit fees.
13,216	4/10/87	Repeals Section 1102.020 and enacts a new Section 1102.020 that adopts the 1987 National Electrical Code without amendments.

15,002	5/24/90	Enacts a new Section 1102.084A that provides for an Elevator Electrical Controls Contractors License.”
15,886	3/24/92	Repeals Section 1102.080 and enacts a new Section 1102.080 that amends the requirements for the examination and licensing of electricians.
16,913	3/21/94	Repeals Chapter 1102 and enacts a new Chapter 1102 that adopts the 1993 National Electrical Code with additional definitions.
17,337	12/19/94	Repeals Section 1102.080 and enacts a new Section 1102.080 that amends the rule making authority of the electrical official and revises the procedures for the revocation of licenses.
18,411	3/6/97	Repeals Chapter 1102 and enacts a new Chapter 1102 that adopts the 1996 National Electrical Code with new and revised definitions, plus permit processing, permit, inspection, and licensing fees.
19870	3/16/00	Removes fee schedule from Electrical Code ordinance (SLCRO 1102) and places Electrical Code fees in Chapter 1100 SLCRO “Code Enforcement Fees Schedule”.
19,998	6/22/00	Repeals Chapter 1102 and enacts a new Chapter 1102 that adopts the 1999 National Electrical Code.
21,553	9/17/03	Adopted 2002 edition of the National Electrical Code (NFPA 70 – 03). Ordinance retained some sections of ordinance 19,998
22,556	11/29/05 (Effective 3/01/06)	Adopted the 2005 edition of the National Electrical Code (NFPA 70 - 05)
24,439	07/13/10 (Effective 11/01/10)	Adopted the 2008 edition of the National Electrical Code (NFPA 70 – 08)
25,574	11/06/13	Amended several administrative provisions.
27,430	06/18/19 (Effective 10/01/19)	Adopted the 2014 edition of the National Electrical Code (NFPA 70-14)
